**Employers must appoint/hire a trained Occupational Safety and Health Coordinator (OSH Coordinator) if he employs five or more employees at the workplace.**

*The penalty for contravention of the requirement to appoint an OSH Coordinator is a fine not exceeding RM50,000 or imprisonment for a term not exceeding six months or both.*
